If your Church or Ministry is unable to meet any of these requests, please let us know so that alternative arrangements can be made, as we are sure Valerie Rogers would still like to come and be a blessing to your Church or Ministry and the set ministry gift. *When unsure, simply ask her.* We thank you in advance for your care, thoughtfulness and gracious hospitality.

Please find a few requests below for your consideration:

Valerie Rogers sometimes travels alone; therefore we respectfully request that arrangements be made to have someone of the same gender greet her at the airport, **if applicable**. Hesed Ministries International prefers to make all travel and lodging arrangements, we ask that as the Host funds the transportation arrangements please include the cost of ground transportation, airfare, luggage and hotel fees as applicable. Our office will provide an estimate in sufficient time to obtain the most economical pricing available. Valerie Rogers will be responsible for her own meals. In the event of a meal being served, she normally enjoys boneless fish.

Valerie Rogers prefers not to eat but enjoys a hot cup of Herbal Tea with 1 teaspoon of honey before ministering the Word of God. Immediately after the preached Word, she would like to have available a glass of Cranberry Juice or Bottled Water at room temperature or slightly chilled (**no ice, please**).

Valerie Rogers prefers to use a lapel microphone or a hand-held cordless microphone. She would also like to receive a DVD and CD of the event if it is available. If recording is not a part of your planning, please let us know if we are permitted to make alternative arrangements.

There is no set honorarium fee to the Host Church or Ministry. However, Valerie Rogers trusts that the Church or Ministry that will be receiving the benefit of the gifts that God has entrusted to her will be fair in honoring the anointing on her life. We at Hesed Ministries International value the covenant of obedience based upon 2 Corinthians 8:12-15 where one seeks the Lord's direction in what to give as an honorarium.
